# Membership Types

## Individual

*An Individual membership shall be applicable only to the named individual, whether married or not. An individual member's spouse or children, if any, shall not be entitled to the privileges of this membership, except as guests, and are subject to the guest policies established by the Club.*

## Family

*A Family membership is defined as any married couple, domestic partners or any two adults from the same immediate family, i.e., sister/brother, mother/daughter. Dependents of family members who are under age 19 are entitled to use of the Club in accordance with our child policies. Dependents, ages 19-24, may be part of their family's membership for an additional monthly fee.*

## Young Individual

*This membership is a discounted Individual membership that is available for people ages 15 - 29.*

## Senior Individual

*This membership is a discounted Individual membership that is available for persons age 62 or older.*

## Senior Couple

*This membership is a discounted membership that is available when either party on the membership turns age 62. (Seniors with dependent children or grandchildren will receive a discount on their joining fee but will be required to pay full family dues.)*

## All Access

*An All Access membership entitles use of the Little Rock Athletic Club, Little Rock Racquet Club, North Little Rock Athletic Club and Downtown Athletic Club for any of the membership types described here. This upgrade can be added or removed at any time.*

## Dependents

*Children ages 3 - 18 may be added to an Individual, Young Individual or Senior Individual membership for \$13 per month per child. Children ages 19 through 24 may be added to any membership type for \$28 per month per child. (There are no dependent charges until a child turns 3.)*

## Important Information

- *Applicable sales tax will be added to all joining fees and monthly dues.*
- *Monthly dues and incidental charges must be paid by bank draft, Visa, Mastercard, Discover or American Express.*
- *Members desiring to upgrade their membership type must pay the difference in joining fees in effect at the date of upgrade.*
- *When children who are affiliated with an active membership reach the age of 25, they must convert their membership to a Young Individual type. In such cases, the joining fee will be waived if dependent dues were being paid for the child for the two months prior to their 25th birthday.*
- *When Young Individuals reach the age of 30, their membership will automatically be converted to Individual.*
